In consideration for the right to occupy an assigned parking space within the residence community, Licensee(s) hereby agrees to make payments to the University in accordance with the rental fees set below. Licensee(s) and University agree to adhere to the terms and conditions set forth in the Housing, Dining & Conference Services License Agreement Parts 1, 2 (Terms & Conditions), & 3 (Terms & Conditions - Policies and Regulations). This Agreement is valid during the time period indicated in the University Park License Agreement Parts 1, 2, & 3 and legally obligates the Licensee(s) to full payment of fees.

Reserved Parking Space Number #_____is herein provided to Licensee to park his/her vehicle in the parking space. The monthly charge for said parking space shall be \$ _____.

1. Reserved Parking fees are due and payable in advance on the 1st day of each and every month (the "Due Date") without offsets, deductions or credits. Reserved parking fee shall be paid to San Francisco State University or such other entity, as the University shall designate in writing.
2. Licensee shall indemnify, defend and hold University free and harmless from any and all liability, claims, loss, damages, or express, including counsel fees and court costs, arising out of the damage to property or the death or injury of any person, including Licensee or any person who is a guest.
3. The Reserved Parking Space Addendum constitutes the sole and entire agreement between University and Licensee respecting the use of the reserved parking facilities by Licensee at University Park.
4. Licensee shall comply with all rules and regulations in effect from time to time for the use of this parking space.

5. This License Agreement is immediately terminable by University if University determines that Licensee has failed to comply with the terms and conditions contained herein or has ceased to be a resident in good standing of University Park.
6. Licensee agrees to pay \$100.00 for any permit that is lost or not returned.
7. Parking permit cancellations must be given 14 days prior to cancelling and must end at the end of the month the License Agreement ends.
